

SCHEDULE OF BENEFITS

Effective 1st July 2019

Option A, Option B and Option C

The Insurers hereby agree to indemnify the insured for claims arising **during the policy period** and for which premiums have been fully paid up but not exceeding the **benefits** applicable. Rogz Pet Insurance will reimburse the Member, on the basis of this Schedule, for eligible Veterinary Services.

Please note: Claims are reimbursed according to the Standard Rate and not what the vet charges. The Standard Rate is calculated by the actuaries and is the average amount charged by all vets across the country, based on our claims data. The Standard Rate treatment list can be downloaded from our Website from 1 July 2019.

Excess / Deductible

The Insured shall be responsible for the first R230 or 16.5% of the applicable benefit of each and every claim, whichever is the greater. Continuation treatment of the same condition within 30 days will carry an excess of 16.5% thereafter benefits are reimbursed at 100% of the Standard Rate for all Options.

A minimum of R330 excess will apply for pets under the age of 13 months at the time of treatment.

Member pays the first $\mbox{\bf R50.00}$ per script for dispensed medicines.

Waiting Period

- You may claim for conditions and Routine and Dental Care (if applicable) which arise one calendar month or longer after the start date of your pet.
- There is a six calendar month's waiting period from the start date of your pet for cruciate ligament claims.

One of each of the below allowed per pet's policy year:

- · Cruciate surgery.
- Incident of swallowing a foreign object requiring surgical or endoscopic removal.
- Back surgery (if eligible).
- General check-up.
